JULY'S ACTION ALERT FROM FCNL

This Month's Action Alert from the Friends Committee on National Legislation

The Action Alert this month concerns the 2001 Authorization for the Use of Military Force (AUMF). This law, passed shortly after the 2001 terrorist attacks, gave the President broad new military powers to fight terrorism. This law continues on the books today, but there has been recent interest in repealing it in Congress. Barbara Lee (D-CA), the only member of either house of Congress to vote against the bill in 2001, recently sponsored an amendment to repeal the law. This garnered 157 votes in favor, not enough to pass, but a strong showing. With the debate likely to continue in Congress over the next few months, all Friends are encouraged to contact their representatives to make your position known.

JUNE BUSINESS MEETING HIGHLIGHTS

The preliminary treasurer's report shows \$9,818 in income and \$9,632 in expenses for 2013/2014.

Adrian Fisher led a discussion in June about Earthcare & Spirituality. No summer sessions of Adult Religious Education are planned for summer.

Kelly Maynard authored a response to a recent Forbes article that draws comparisons between Vladimir Putin and Adolf Hitler. The Forbes article recommends a US military presence in Ukraine and supplying the former Soviet states with oil produced by fracking to lessen their energy dependence on Moscow.

Kelly's response, approved for submission to Oak Leaves, the Chicago Tribune, and Forbes, points out in a poignant way the drawbacks of these strategies.

OUERY OUOTATIONS

Rooted in the history of Friends, queries reflect the Quaker way of life, reminding Friends of the ideals we seek to attain. We approach queries as a guide, using them not as an outward set of rules, but as a framework within which we assess our convictions and examine prayerfully the direction of our lives and the life of the community. Here are a few selections from Faith and Practice, published in 1997 by Philadelphia Yearly Meeting of the Religious Society of Friends:

7. Social Responsibility and Witness

How does our Meeting work:

- to overcome social, legal, economic, and political injustices, locally and in the wider world?
- for the funding of community services that does not rely on gaming income?

Does our Meeting serve the community through action on concerns for civic improvement? What actions are we taking to assure everyone equal access to education, health care, legal services, housing, and employment as well as equal opportunities in business and in the professions?

When a member has lifted up a concern, how does our Meeting respond?

Does our Meeting encourage those seeking clearness for their convictions of conscience to hold up such convictions with prayerful openness to the Light?

Am I mindful of how my lifestyle and my investments can contribute to the improvement of the human condition, or to the exploitation of others?

Am I open to seeking clearness on matters of conscience and to assisting others in doing so? How do I respond and support one who acts out of a clear leading when I am under the weight of another?

What am I doing to work for the betterment of my community to assure the maintenance of effective public services which do not rely on funding from gaming?

Do I fulfill my civic responsibilities when they do not conflict with divine leadings?
